Privacy Policy

This Privacy Policy explains how 6Q Music Production ("we," "our," or "us"), as the Data Controller, collects, uses, and protects your personal information when you use our non-transactional website hosted on the Wix platform. By using our website, you consent to the practices described in this policy.

1. Information We Collect

We collect the following types of information:

Basic Member Details

- I. Full Name
- II. Email Address
- III. Username
- IV. Password (stored securely using encryption)

Songwriting files

- I. Musical Scores
- II. Lyrics
- III. Song Arrangements

Audio and Video Files

- I. Audio files uploaded or shared as part of the music production process.
- II. Storyboards and video clips related to music video production.

Technical Data

- I. IP address, browser type, operating system, and device information.
- II. Cookies and usage data (see Section 7 for details).

2. How We Use Your Information

We use your information for the following purposes:

I. To create and manage your membership account.

- II. To facilitate the music production process, including sharing and receiving audio files, storyboards, and video clips.
- III. To communicate with you about your account, updates, or website-related information.
- IV. To improve our website and services based on user feedback and usage patterns.
- V. To comply with legal obligations and enforce our terms of service.

3. Legal Basis for Processing (GDPR Compliance)

Under the GDPR, we process your personal information based on the following legal grounds:

- I. Consent: When you provide explicit consent (e.g., for cookies or specific data processing activities).
- II. Contractual Necessity: To fulfill our obligations under the membership agreement.
- III. Legitimate Interests: To improve our services and ensure website security.
- IV. Legal Obligations: To comply with applicable laws and regulations.

4. Data Sharing and Transfers

We do not sell, trade, or rent your personal information to third parties. However, we may share your information in the following circumstances:

- I. With Wix, our website hosting provider, to enable website functionality.
- II. With third-party service providers who assist us in operating our website (e.g., email services, cloud storage).
- III. When required by law or to protect our rights, property, or safety.
- IV. With your explicit consent.

If your data is transferred outside the European Economic Area (EEA), we ensure adequate safeguards are in place, such as the Data Privacy Framework (DPF) or Standard Contractual Clauses (SCCs).

5. Data Security

- I. Wix uses reasonable measures to protect your personal information, including:
- II. Using SSL/TLS encryption to secure data transmissions.
- III. Storing passwords and sensitive data in encrypted formats.
- IV. Regularly reviewing our data collection and storage practices.
- V. Limiting access to your information to authorized personnel only.
